# Salute: Benevolent Fund Packing Crew

Panorama residents have stuff. Lots of stuff. And no one knows that more than the Benevolent Fund Patio Sale Packing Crew. When the Panorama Corporation notifies the Benevolent Fund that a residence has been vacated, Diane Stiles and Jo Love Beach do a walk through to check for furniture that needs to be picked up and to estimate the amount of boxes and paper needed for packing. The Patio Sale Packing Crew Lead estimates the number of volunteers needed to get the packing done in two hours or less and puts a Crew together. Each Crew consists of a minimum of two people and usually no more than six. Most of the time we meet our two hour goal but not always. Occasionally a second shift needs to be set up to finish the job.

Some jobs require only 4–5 boxes but sometimes as many as 80–100 are needed. The average is probably 40–50 boxes. There are currently about 15 volunteers who are called on to work once or twice a month. It is difficult to predict

# Patio Sale—Merge two events?

The Patio Sale Succession Planning Team recommended that Santa's Shop at the Barn and Christmas Comes Early merge. After deliberation the Board of Trustees decided such a merger would not be in the best interest of either group under current circumstances and that the recommendation would not be implemented at this time.

Characteristics considered during this review:

Historical development and audience/sales targets. Santa's Shop began in 2003 as an activity directed toward provision of Christmas items for purchase by residents. Santa's Shop has historically occurred on the first weekend in December. Christmas Comes Early may have begun as a bake sale in the 1990's; the history is not totally clear. The date for this event has varied from early fall to the weekend prior to Thanksgiving. The audience, while it includes residents, is more focused on non-residents.

**Products for sale.** Santa's Shop offers the buyer everything from artificial trees, outdoor lights and yard art to fine linens and collectibles as gifts. It also includes tree decorations, package decorations and wrapping paper. Christmas Comes Early currently offers the buyer a variety of handcrafted gift items ranging from jewelry to pen and pencil sets or clothing accessories, and books from the Panorama Benevolent Fund.

**Proceeds from Events**. The funds collected go to support different activities and organizations. Christmas Comes Early funds benefit the individual vendor/artist (80%) and the Resident Council activity fund (20%). Santa's Shop receipts go to the Panorama Benevolent Fund account in support of its mission.

**Space for Event Parking.** Should there ever be interest in holding the events on the same weekend, there would need to be significant pre-planning with Panorama due to parking limitations and traffic congestion.

**Developing/Continuing Responsible Groups.** Both activities appear to be resident driven and supported. Like many volunteer activities, they have probably changed considerably from inception based on growth, additional ideas, and the abilities found in the volunteer groups.

This Succession Planning recommendation did not generate any appreciable degree of interest or support from the Christmas Comes Early group for current or future consideration. This article serves to record the consideration of the recommendation on the part of the Benevolent Fund Board and also serves as the basis for not implementing the recommended merger of these two activities at this time. This recommendation may be marked as essentially completed until there is some basic change in one or more of the fundamental characteristics of either one of the activities. At that time the issue can be reopened and reexamined in light of the changes. •



### PACKING CREW

when or how many residences will be vacated at any given time, so crew members usually only have a few days' notice to complete a job. During 2015 we packed up over 65 residences.

Packers need to be reasonably fit, able to bend and reach, and do some light lifting and carrying. Decision making is also a big part of packing. Pack? Toss? Bag? Box? Hand carry to Barn? But with practice, it gets easier and faster. Items that could be damaged (cracked, chipped, or squashed) in packing or transporting may be set aside to be hand delivered to the Patio Sale Barn by the crew leader. Papers with personal information are reviewed to determine proper disposition. We direct as many items as possible to the recycling center or the food bank. Medications are taken to the pharmacy on campus for disposal. Firearms and narcotics go to the police department. Clothing is bagged up for ARC. When all the packing is complete, the Barn is notified and the Pickup Up Crew transports the boxes, bags, and other designated items to the Barn for pricing, sales, or repacking and moving to storage.

Crew members quickly understand how sensitive this job can be, and so we do our work with a sense of respect and privacy. When you enter a vacated residence it contains many elements of the former occupant's life. As you sort through the cupboards, closets, and drawers you run across family photographs, awards and certificates, souvenirs, and many personal items. Depending on the nature of the items and where they are found, the former resident or resident's family may be contacted to assure that leaving the item was not an oversight. Among the many beautiful and amazing things, there can be evidence of successes and losses; glimpses of a sense of humor or personality; and a picture of their daily life. We are very mindful of that.

Packing is hard work, so what keeps us coming back for more? A sense of accomplishment, the satisfaction of having contributed to our community, and the camaraderie resulting from the shared experiences of the crew are a few obvious reasons. One side effect that might not be so obvious is the development of a strong urge to go home and clean out our closets. \(\infty\)

And oh, the goodies for sale; strings of lights, trees (decorated and plain), wreathes, bells, bows, linens, toys, doll houses, collectibles, decorative tins, trinkets, art and anything else you can think of to decorate the home or use as a gift.

The warm spirit and the cheery atmosphere inside the barn were in direct contrast to the wet and cold rain and wind outside. In spite of the weather, the proceeds from this year's event set a new record of \$3,839. Thanks to each and every one of the many volunteers who made this event possible—and to all of the shoppers who found just the right thing to complete their decorations or to add to the holiday spirit.

Although not directly related to Santa's Shop, or even directly to the Christmas season, the following story was shared with me the other day. The Patio Sale activity receives greeting cards donated by residents and then makes the cards available to other residents in each of the apartment buildings. There is a network of distribution and oversight within each site. One of the individuals who is a part of this network shared with me that after looking back to just the holiday cards processed in 2011 they collected \$48.71. The amount collected for holiday cards rose and fell a bit since 2011 for no apparent reason each year. But this year they collected \$101 just for holiday cards! While this is not a complete accounting of all the sites, or for any other time of year, it just goes to show that many residents use the services of those who volunteer year after year in special, quiet, and often invisible ways. Our thanks go to each and every one of these special and thoughtful volunteers!

As I complete what I expect will be my last report to Fund Facts as president of the Benevolent Fund, I would share with you the following: "Life is not about surviving the storm, but about dancing in the rain." I do not know who said it first or how long it has been around, but I hope each of you has a chance to experience the joy and wonder of dancing once more in the rain! •
